- 1. Chair Rose Roy called the meeting to order at 12:15 pm. The Board meeting was held with members attending virtually or in person.
- 2. Attendance: Chair Rose Roy called roll. Judge Miller requested an excused absence for the June 20<sup>th</sup> in-person meeting. Billie Ratliff requested an excused absence for the June 7<sup>th</sup> and 14<sup>th</sup> electronic ballot voting. Mark Allison requested an excused absence for the June 14<sup>th</sup> electronic ballot voting. Ashleigh Pratt requested an excused absence for the September in-person meeting.

#### 3. Case Review:

- a. **VRA Statements:** Statements provided by victims or victim representatives for offenders McDermand-Wyland, Hoffman, and Hentosz.
- b. Discussion and Balloting: No Discussion, Balloting was opened.
- 4. Approval of Minutes: Billie Ratliff moved, and James Allen seconded to approve the meeting minutes for April 18th, 2023, and the electronic meeting minutes for April 5<sup>th</sup>, 12<sup>th</sup>, and 26<sup>th</sup>, 2023. The motion passed unanimously by roll call vote.

#### 5. Program Reports:

a. <u>Embrave (ECC)</u>: Mark Wester reported for Embrave. He stated that they are currently allocated for 234 beds; Child Support collected was just under \$4,000, and climbing and restitution collected was just under \$5,000; For the month of April, they had 38 admissions with 38 residential and two non-residential terminations; Successful completions were down this past month to 47.7%, totaling 17; Negative terminations were up to 55%, totaling 21, with 11 of those being escapes. Mr. Wester reports staffing is down due to a wave of staff turnovers; Embrave currently has seven vacant security staff FTEs, four case manager positions, one clinician for the RDDT program, and two support staff positions. Mr.

Wester reports that the client employment rate was at 78%, up 2% from the previous month; The UA positive rate was at 1.9%; There were four client grievances during the month of April; Mr. Wester reported a total of 50 Diversion referrals and 82 Transition Referrals for the month of April; Mr. Wester reported on Embrave's PACE audit, stating that they continue to conduct leadership development at weekly management meetings and they have provided Mental Health First Aid training to staff. The Narcan administration signs of overdose courses have been taught on an ongoing basis to staff, and Embrave continues to pursue harm reduction strategies implemented in their facilities. KPIs with involuntary staff terminations have been lowered to 33% in April. The average length of service for staff is currently at 4.2 years; The fourth KPI is being tested, which is the goal of 75% of staff identifying that they have adequate training. A Kirkpatrick survey will be given to staff in July to get feedback on this goal.

Mr. Wester provided follow-up information to the board regarding a reported client assault in March. The offending client was in a mental health crisis, and as staff attempted to deescalate the situation, he assaulted another client in the parking lot. There were no reported injuries, and the victim declined to press charges. The offending client was terminated. Mr. Wester was asked to clarify Embrave's administrative review process and time frames. Mr. Wester reports that the administrative review must occur within three weeks from the termination date. Mr. Wester provided information regarding clients with mental health issues, specifically with medication management, the right to medication refusal, and Embrave's limited ability to provide the necessary mental health treatment and tools for clients with serious mental health conditions. Mr. Wester reports that he toured Larimer County's community corrections program and learned about a program that provides support and resources to clients with mental health concerns who are justice-involved. He stated that he would be sharing this information with EPC staff.

The board asked Mr. Wester why renovations had stopped at the 3950 facility. He explained that it is one of their older facilities and requires extensive and costly renovations. Embrave's strategic plan is to redevelop the 3950 with a completely new building.

b. <u>Community Alternatives of El Paso (CAE)</u>: Sean Foster reported for CAE. Mr. Foster provided follow-up information to pending Board member questions from the last meeting; He provided additional information concerning the following: The type of drug found previous month was methamphetamine, Informed Trauma is a training class offered to both staff as residents, and dangerous drugs are those identified and screened for on the 30-panel UA test. The CAE bed capacity for April was 188; Mr. Foster reports that total child support collected was at \$9,700 and restitution collected was \$9,236; Mr. Foster said there were 29 admissions and 31 terminations, with four of those being non-residential clients; The successful program completions rate dropped to 40.6%, and the negative termination rate was at 59.4%, which included 13 escapes; Mr. Foster reported that a residential house meeting was held to discuss the concern with the high number of escapes occurring and to

remind clients of the negative consequences of committing and escape. CAE currently has two Security Technician vacancies and one case manager vacancy; Mr. Foster reported that CAE's client employment rate has slightly risen to 77.2%; He reports that the current positive UA rate is 3.25%; CAE is reviewing current client medications to determine if these are impacting positive UA rates. There were eight medical emergencies during the month of April, with one incident requiring an ambulance; Mr. Foster reports one client death in April that occurred off-grounds with a female client who was in hospice care; Mr. Foster reports that there were 44 Diversion and 59 Transition Referrals in April; For the PACE audit, all case managers attended Progression Matrix and Case Planning training provided by DCJ. The Case Manager Supervisor and Program Manager will continue to provide feedback with the audits and assessments, including earned time calculations; All staff attended Sexual Harassment in the Workplace as well as PREA training in April; Mr. Foster reported that a canine search was conducted in April with no major contraband discovered; Mr. Foster reported that the anonymous contraband drop box was installed in the front of the facility. He provided additional clarification that the box was installed in April and that it is checked by staff weekly, but that there have been no contraband items placed in the box to date; Mr. Foster reported that the Key Performance Indicators show the current employee retention rate at 66.7%, with the case manager retention rate at 70.6%; Core Correctional Practices training is up to 35% with additional training in Security Practices and MI being scheduled in the next two months.

Mr. Foster fielded questions from the board concerning a reported assault during the month of April; The assault involved a client being knocked down in the bathroom by another client; There were no reported injuries, but as a result, the assailant was terminated from the program.

#### 6. Monthly Reports:

- a. <u>SFY23 Financial Report</u>: MaCain Hildebrand reported the April 2023 expenditure reports. For April FY23, the expected YTD expenditures should have been at 83.33%. Embrave was at \$5,711,056.38 expended, representing 5.64% overspent. CAE was at \$3,715,392.65 expended, representing 19.79% underspent.
- b. <u>Provider Termination Report</u>: MaCain Hildebrand reported that for April 2023, Embrave had a 45% positive/successful termination rate, a 29% unauthorized absence termination rate, and a 26% technical violation termination rate. He reported that Community Alternatives of El Paso County had a 39% positive/successful termination rate, a 42% unauthorized absence termination rate, and a 19% technical violation termination rate.
- c. <u>Staff Report:</u> MaCain Hildebrand reported that Christine Burns, Board Member Chantel Bruce, as well as himself, will be attending the Colorado Association of Community

Corrections (CACCB) annual meeting on June 2<sup>nd</sup> and 3<sup>rd</sup> in Montrose. Board member Mark Morgan accepted a position as the City Attorney for Durango, CO; his last day as a board member was April 18, 2023. Board member Dr. Judy McCollum is retiring and moving to Florida; her last day as a board member was May 3, 2023. EPC staff wish them well in their new endeavors and thank them for serving the board and the community.

#### 7. Old Business:

a. <u>Denver Contracts for CC Beds:</u> MaCain Hildebrand reported that the EPC staff have withdrawn their agenda item proposal regarding the Denver Transition Waitlist. This matter was initially presented on April 18, 2023. The Board was asked to accept Denver Community Corrections Board criteria and approved, waitlisted transition clients for placement in El Paso County without additional local Community Corrections Board approval. The Board requested a working group session to obtain additional information on this matter. The working group session was held virtually on May 2, 2023, with no action taken.

#### 8. New Business:

- a. <u>CJIS Level II Security Training:</u> Christine Burns reported that Board members would be asked to review security training information and complete a Security Awareness Level 2 test to obtain certification. Board members were also advised that they are required to complete a minimum of four hours of training per year on criminal justice-related topics, with at least two hours specific to community corrections.
- b. <u>CAE Second Half Facility Payment:</u> Christine Burns reported that CAE had submitted a letter of compliance in meeting the DCJ Statewide Facility Payments Policy. She requested Board approval for the 2<sup>nd</sup> half of the SFY23 Facility payment distribution to CAE in the amount of \$74,000. Rose Roy moved, and Chantel Bruce seconded to approve the facility payment to CAE. The motion passed unanimously by roll call vote.
- c. <u>CAE Staff Hiring Waiver Request:</u> Sean Foster requested board approval for hiring a qualified candidate with a previous criminal record. The candidate was convicted of 2<sup>nd</sup> Degree Attempted Murder and Robbery in March of 2015 and completed a sentence in the Youthful Offender System. The board requested additional vetting information regarding the circumstances surrounding the charges. Deborah Mynatt moved, and Billie Ratliff seconded that motion to carry over the vote until further information could be presented at the next meeting. The motion passed unanimously by roll call vote.
- 9. Case Review Ballot Results: The Chair read the ballot results.
- 10. Board/Staff Comments: No comments
- 11. Adjournment: Chair Rose Roy adjourned the meeting at 1:18 p.m.





There are 22 community corrections boards in 22 Judicial Districts. The number of board members Statewide is more than 300. The categories of membership include citizen, Human Services, Public Defender, Probation, Department of Corrections, Division of Youth Corrections, District Attorney, law enforcement agencies, court and elected officials.



Offenders placed in community corrections are required to work and pay for their room and board, court costs, treatment programs, fines, restitution and court ordered child support. They are required to pay federal, state and local taxes and participate in offense-specific treatment. Those without a high school diploma are required to work toward their GED.

#### **COMMUNITY CORRECTIONS PROGRAMS**

- In FY21-22, 27 residential community corrections facilities provided services for both male and female offenders.
- Three of these programs were exclusively for women offenders; several are specialized residential treatment programs.
  Programs are audited for compliance with State Standards by the Department of Public Safety's Division of Criminal
- Justice in conjunction with the local community corrections board.

### **Background Information:**

The Office of Community Corrections (OCC) Colorado Community Corrections Standards 2022 outlines a process for a waiver request. Standards recognize that a need may arise to request an exemption from certain provisions of the *Colorado Community Corrections Standards*. Such exemptions may be sought for good cause through the waiver request process.

A waiver request shall first be submitted in writing to the program's local board. While no specific format is required, each waiver request shall reflect, at a minimum, the specific Standard(s) for which an exemption is sought, a description of the desired exemption (for example, whether exemption is sought from the entire Standard or only a portion thereof) and a statement of why the requested exemption will not adversely impact public safety, offender treatment, offender management or the administration of the community corrections system.

The local board shall determine whether the requested exemption should be granted in whole or in part or be denied. Such determination shall be in writing. If the board denies the request for a waiver, the matter is considered closed.

If the local board approves all or part of a waiver request, it shall transmit that approval and all supporting materials from the original waiver request to the Office of Community Corrections of the Division of Criminal Justice. The OCC may approve the request, as submitted by the local board, and may so notify both the board and the program that the exemption has been granted.

In the alternative, the Office of Community Corrections may determine that an exemption approved by the local board should not be granted. If it intends to deny a waiver request that has been approved by the local board, the Manager of the OCC shall first consult with the Director of the Division of Criminal Justice or such person acting in that capacity. If the Director concurs, the Office of Community Corrections shall communicate to the local board and the program that the waiver request is denied. The matter is then considered closed.

Community Alternatives of El Paso County and Embrave have submitted the attached written requests for Board endorsement to modify provisions within the Colorado Community Corrections Standards.

This letter serves as Community Alternatives of El Paso County's request for a waiver from DCJ Standard CS-044: Home Visits and Community Contacts to the El Paso County Community Corrections Board. The standard states the following:

### CS-044: Home Visits and Community Contacts

Home visits and community contacts are required for all non-residential clients. Prior to the client's transition to the residence, staff must physically enter the client's home and perform a home visit. All future home visits and community contacts shall be performed at the frequency described in the grid below. During a home visit, staff must physically enter the client's home and check for indications of the client's stability and level of functioning.

Due to the potential danger staff face in conducting home visits because of other justice-involved individuals who may be at that residence, CAE requests a waiver from this standard. We believe the intent of the standard can be met by utilizing technology (resident using their cell phone to view the inside of the residence, teams meeting, etc.), meetings outside of the residence, and meetings in the community.

The process added to policy would consist of the following:

- Prior to the resident's transition to the residence, the designated non-res case manager, will utilize the CAE security phone to conduct a virtual assessment of the inside of the residence by connecting with the resident's cellphone to check for client stability and level of functioning. The address will be confirmed.
- A Teams Meeting, or similar computer to cell phone connection can also be used.
- All future home visits will be conducted in the same manner and/or outside of the residence.



### **CS-044: Home Visits and Community Contacts**

Home visits and community contacts are required for all non-residential clients. Prior to the client's transition to the residence, staff must physically enter the client's home and perform a home visit. All future home visits and community contacts shall be performed at the frequency described in the grid below. During a home visit, staff must physically enter the client's home and check for indications of the client's stability and level of functioning. Community contacts may be conducted at a prearranged community location, such as a coffee shop, library, or other public location. The staff may conduct an IMPACT meeting during a home visit within the home or community contact and occasionally include support persons with whom the client cohabitates, if applicable. Staff conducting home visits or community contacts must take into consideration the client's schedule prior to determining the timing of the visit or contact. Home visits and community contacts may be conducted on an alternating basis to meet the required frequency. Community contacts cannot be conducted consecutively. Programs are responsible for determining staff safety practices while conducting home visits or community contacts in accordance with the *Standard*.

Embrave respectfully requests a waiver for DCJ standard CS-044, Home Visits and Community Contacts as written below.

### CS-044: Home Visits and Community Contacts

Home visits and community contacts are required for all non-residential clients. Prior to the client's transition to the residence, staff must physically enter the client's home and perform a home visit. All future home visits and community contacts shall be performed at the frequency described in the grid below. During a home visit, staff must physically enter the client's home and check for indications of the client's stability and level of functioning. Community contacts may be conducted at a prearranged community location, such as a coffee shop, library, or other public location. The staff may conduct an IMPACT meeting during a home visit within the home or community contact and occasionally include support persons with whom the client cohabitates, if applicable. Staff conducting home visits or community contacts must take into consideration the client's schedule prior to determining the timing of the visit or contact. Home visits and community contacts cannot be conducted consecutively. Programs are responsible for determining staff safety practices while conducting home visits or community contacts in accordance with the Standard.

Embrave requests a waiver for this standard due to the following concerning issues.

- Conducting residence verifications, home visits and community contacts, hereafter referred to as **community visits**, pose an unnecessary safety risk for staff. Our clients often reside in lower income neighborhoods because of the high cost of living and a lack of affordable housing options in El Paso County. Lower income neighborhoods are often also high crime neighborhoods. Our staff do not carry weapons and have no training in or experience with personal defense, threat assessment or legal authority.
  - a. The safety threat that exists during community visits is often not directly tied to our clients. We believe the primary threat comes from the people in and around the residence such as friends, family members and neighbors. It is not uncommon for our clients to have criminal associates or family members and to live close to others with criminal records. While our clients may have an interest in trying to maintain a safe and secure environment for our staff, others do not.

Conducting community visits in a client's home also creates the possibility that staff members could find evidence of illegal activities such as the presence of illegal drugs, weapons, or persons with active warrants. This creates an extremely dangerous situation for our staff who are often seen by people in the system as unarmed "cops".

b. Community corrections staff are not trained in threat assessment and do not know how to respond to threats that may present themselves. Threat

assessment training includes, but is not limited to, spotting the presence of gang activity, identifying behavior-based threats, assessing a specific individual's risk for violent behavior, and recognizing the signs of drug activity. They are also not trained in appropriate and safe responses to these kinds of threats. The Colorado Springs Police Department trains new recruits in officer safety and threat assessment as a part of their 27-week academy. It is not feasible or safe to have our staff trained in threat assessment because to be safe and effective, they would need other supporting and ancillary law enforcement training as well as the legal authority that police and parole officers have.

2. Technology provides us with alternatives we can use to verify addresses, view client's homes, and speak with family members through commonly used platforms like FaceTime, Zoom, Skype and Google Duo. Using this technology, we can see inside the client's home and speak with the client and their family members in real time with no threat to the safety and security of our staff. There is no real difference between the information gathered during an in-person community visit and one conducted virtually, the only difference is the way in which the information was gathered and the complete elimination of risk to the safety of our staff. Conducting in person community checks brings little value to the process when compared to virtual visits.

It is our hope that the Board will vote to allow for a waiver to this standard. We believe this standard poses an unacceptable level of risk to our staff without bringing any real value to the process that would justify that risk. We take the safety and security of our staff and clients very seriously and believe that virtual community visits are a safe and feasible alternative to the existing requirement for in-person community visits.

Policy: It is the policy of Embrave to inspect the prospective residence prior to the client being approved to progress to non-residential status. After the initial home visit, staff will perform regular inspections of the client residence to ensure the residence continues to be safe and appropriate.

### Procedure

- A. Initial Home Visit
  - a. Clients who have completed level 4 of the matrix, and are preliminarily approved for non-residential placement, will have a virtual home visit scheduled. Once the required approvals are in place, the case manager will schedule the virtual home visit through the non-residential staff.
  - b. Virtual home visits will be conducted using a platform for virtual meetings such as Zoom, Google Duo, Teams or Skype.
  - c. During the virtual home visit, staff will instruct the client to use an electronic device, such as a phone or tablet, to show the staff around their residence and to electronically speak with any other person living in the residence.
  - d. The staff member conducting the virtual visit will document it using the home visit form.
  - e. Staff will verify the client's phone is operational or verify the current approved location app is correctly installed and operational on their approved call phone.
  - f. After the conclusion of the virtual home visit, the staff will discuss the non-residential weapon removal notification and the nonresidential advisement form with the client. The client will acknowledge understanding of the forma with a signature.
  - g. Staff will document the virtual home visit and their findings in a chron in the client's electronic record.
- B. Continued Home Visits: All clients on non-residential status will have continued virtual home visits in accordance with DCJ standards.

The Colorado Coalition of Community Corrections, in partnership with the Colorado Department of Corrections and the Office of Community Corrections, has agreed to a Memorandum of Understanding (MOU) to implement a more standardized approach to the Administrative Review process for terminated Transition clients. The MOU ensures written communications regarding termination notifications and establishes clearly defined timeframes for clients to request a review of termination actions in addition to requirements for provider decisions. The established procedures will be included in CDOC Administrative Regulation 250-15, *Community Corrections Program Supervision Standards*.

### Memorandum of Understanding

Colorado Dept. of Corrections, Colorado Community Corrections Coalition and Division of Criminal Justice-Office of Community Corrections

### Introduction

While Community Corrections providers have autonomy to create their own policies to meet federal, state and local standards, they also recognize the benefits to their Transition client population and the Dept. of Corrections to align their practices to meet the Administrative Review Process statute.

17-27-104. Community corrections programs operated by units of local government, state agencies, or nongovernmental agencies 17-27-102. Definitions

### **Purpose of Agreement**

The purpose of this MOU is for providers to implement a more standardized approach to the Administrative Review Process for Transition clients.

### **Description of Agreement**

The Colorado Coalition of Community Corrections providers agree to the following in the Administrative Review Process for Transition clients:

- Written communication (aka DOC Termination Notice Technical Violation) shall be provided to a Transition client upon a program termination for a technical violation or reject after acceptance will state the client will have 5 business days to submit a request to the provider for review of their termination.
  - This written communication (aka DOC Termination Notice Technical Violation or DOC Termination Notice - Reject After Acceptance) will include an email address(es) so the client is able to electronically submit a request for Administrative Review to the termination action.
- The client's request will be accepted by mail or electronically (i.e. email) and may be initiated by the client's Parole Case Manager, Dept. of Corrections Case Manager, Office of Community Corrections staff, support/community sponsor, or the client themselves.
- The provider will review and communicate within 5 business days its decision to the client of the outcome of the review of their termination.
- The Parole Case Manager is the supervising agent for a client who is residing in a local jail upon termination, and will act as liaison for a client who is a direct book to a DOC facility upon termination.
