1. **Pat Kelly, Board Chair called the virtual meeting to order at 12:01 p.m.**
2. **Attendance:** Pat Kelly called roll. No requests for future excused absences were received.
3. **Case Review-VRA Statements:** Victims in Transition client cases (Dominique Vallejos and Kyle Zoller) addressed the board.
4. **Case Review – Discussion and Balloting:** Pat Kelly called for case discussion with no cases called.
5. **Approval of the Minutes:**

**Mark Allison moved to approve the meeting minutes for February 10, 2021, and the electronic meeting minutes for February 3, 17, and 24, 2021. Martha McKinney seconded the motion. The motion passed unanimously by roll call vote.**

**6. Program Reports:**

**a. Community Alternatives of El Paso County (CAE)**

Scot Smith reported an average census of 171. He stated that there were 39 clients on non-residential status; that they had one transfer to IRT; that they had ten escapes; that they had 24 positive UAs with 3 from medications; and that they had a 73% positive employment rate. Mr. Smith stated that leadership staff have started monthly unannounced audits; that they added a “Women in Recovery” group; and that they have begun to utilize the Carey Guide system to support offender behavior change and recidivism reduction. In response to a question from Judge Miller, Mr. Smith stated that CAE immediately quarantines newly admitted offenders for fourteen days with daily temperature checks. Frances Falk stated that case managers work with clients and employers to support job maintenance; that subsistence is not charged during this time period; and that the process has worked out well having been developed in collaboration with the El Paso County Health Department.

**b. ComCor, Inc. (CCI)**

Mark Wester reported an average census of 256. He stated that they processed 96 referrals; that they had 63 admissions; and that they had 37 terminations of which 20 were unsuccessful and 17 were successful. He stated the employment rate was at 69%. Mr. Wester reported

that they are experience staff turnover with diligent recruiting efforts; that Dr. Sue Kuiper has been selected as the new Client Services Director; that they formed a client consultative committee to support a stronger continuous quality improvement process; that they are in the middle of the Division of Criminal Justice's PACE audit process; and that they are working with an independent consultant on internal cultural matters and should expect a report shortly. In response to the previous question from Judge Miller, Mr. Wester reported that in collaboration with the El Paso County Public Health Department and because of the congregate living facility, clients are quarantined upon admission; that employers are very understanding; that they complete weekly surveillance testing; and that they are not on outbreak status.

**7. Monthly Reports:**

- a. **SFY21 Financial Report:** Christine Burns reported the expected expenditure for the period July 1, 2020 through January 31, 2021 was 58.33%. She stated that CAE was at 41.65% spent representing a 16.69% under expenditure, and that CCI was at 61.67% spent representing a 3.35% over expenditure.
- b. **SFY21 Unauthorized Absence Report:** Christine Burns reported that for the January 2021, the unauthorized absence rate for Diversion clients was 32.4% and 17.9% for Transition Clients. She reported the successful completion rate for Diversion clients was 32.4% and 48.7% for Transition clients.
- c. **Staff Report:** Christine Burns stated that a Board member feedback survey has been developed by Kristen Sanchez the criminal justice graduate intern related to the evidence based decision making tool, training opportunities and continuous quality improvement, and for the Board to expect an email with a link to the survey. She stated that the current Division of Criminal Justice IRT contract with ComCor, Inc. has been extended until June 30, 2022. She reported that the Division of Criminal Justice plans to decrease the current fiscal year contract by \$1,000,000 due to the CO Joint Budget Committee's negative supplemental.

**8. Old Business:**

- a. **Citizen Complaint Process:** Christine Burns stated that the Board approved a citizen complaint administrative procedure in July 2017; that the revised procedure was presented at the January 2021 meeting for Board and public input; and that staff recommend Board approval of the revised Citizen Complaint Process.

**Mark Allison moved to approve the proposed Citizen Complaint Process effective immediately. Janice Helman seconded the motion. The motion was unanimously approved by roll call vote.**

- b. **DCJ Approval of CCI Standards Waiver Request:** Christine Burns informed the Board that the Division of Criminal Justice approved through June 30, 2021 the standards waiver request endorsed by the Board at the February 10, 2021 meeting.

**9. New Business:**

- a. **Office of Community Corrections Audit Results – ComCor, Inc.:** Mrs. Burns stated that staff worked closely with the Division of Criminal Justice, Office of Community Corrections to investigate and audit several staff and client complaints. She thanked ComCor staff and Mr. Wester for their cooperation, participation and sense of purpose and immediacy in the process. Mark Wester provided details on the incident specific audit and stated that the CRP client house rules policies and procedures are being updated to meet SOMB guidelines and that program rules have been revised and will continue to be revised; that the cultural and personnel issues from the complaints are being investigated through a third party contract; that the client case file issues and the furlough and time credit concerns were substantiated; that attempts were made to recover staff deleted client files but were unsuccessful; that a new perpetual backup system has been activated; and that internal procedural audits and monthly time calculation plans have been implemented.
- b. **Standards Waiver Request – GEO Group/CAE:** Scot Smith presented a request for Board endorsement of GEO Group’s modification of certain Community Corrections Standards due to COVID 19 and safety concerns. Mr. Smith gave an overview of the standards modifications as requested.

**Rose Roy moved to endorse GEO Group/CAE’s request to modify provisions within the Colorado Community Corrections Standards as submitted in response to limiting the spread of COVID-19 and approve transmittal of the Board’s decision to the Office of Community Corrections. Gil Suazo seconded the motion. The motion passed unanimously by roll call vote.**

- c. **Colorado Community Corrections Annual Report SFY20:** Christine Burns presented the Division of Criminal Justice’s annual report on community corrections as mandated under House Bill 18-1251 and stated that it included statewide and local data on community corrections trends, acceptance rates, and progress on the implementation of structured decision-making.
10. **Study Session – Department of Corrections Q & A with Case Manager:** A Q&A session was held with Chrystal Owin from the Division of Criminal Justice and several case managers from the Department of Corrections. Board members and case managers interacted with questions and answers. The study session was held to allow for a shared collaborative, constructive feedback opportunity to improve efficiency in the referral process.
  11. **Case Review – Ballot Results:** Results of the ballot were read.
  12. **Board / Staff Comments** – No additional board or staff comments.
  13. **Adjournment:** Meeting adjourned at 1:33 p.m.
